## Nagorno-Karabakh Republic

Second international expert conference **"The Dialogue of Nations. The right of peoples to self-determination and building of a multipolar world" states:**

The Nagorno-Karabakh Republic, or Artsakh Republic, was formed as a result of a national referendum on state independence on 10 December 1991, in full conformity both with the UN Charter and international law, and the laws of the USSR (the USSR Law of 3 April 1990 "On the procedure for the solution of the questions connected with the withdrawal of the Union Republic from the USSR"). March 11, 1999, in Strasbourg, the European Parliament adopted a resolution on Nagorno-Karabakh "On maintenance of the peace process in the Caucasus", which acknowledged "the fact that the Nagorno-Karabakh Autonomous Oblast' declared its independence after the similar steps of the former Soviet socialist republics after the collapse of the Soviet Union in September 1991." (June 21, 1999. Official journal of the European Communities, C175/251. [http://www.mfa.am/u\\_files/file/nk-rus\\_2014.pdf](http://www.mfa.am/u_files/file/nk-rus_2014.pdf)). Thus, the international legal validity of the proclamation of Karabakh's independence was recognized, similar to other Soviet republics. International law imperatively dictates the necessity of the recognition of the Nagorno-Karabakh Republic.

The successful development of the Karabakh state is one of the systemic factors of the regional and global security. During the repulse the act of the terrorist aggression of Azerbaijan in 1991-94 and in April 2016 the Nagorno-Karabakh Republic (NKR) had to maintain an operation to force Azerbaijan to peace. The NKR defense Army has been actually performing a peacekeeping function for long years.

The Nagorno-Karabakh Republic has all UN membership qualifications. Nagorno-Karabakh has managed to build a stable democratic society and state, with all criteria of full independence: a territory, a permanent population – the citizens of the state, the formation of legitimate bodies of political power and their control over the territory of the Republic, the ability to conduct international relations and fulfill international obligations. The NKR pursues an active foreign policy, establishes relations with other states and international organizations, sends official representatives to negotiations, and participates in international organizations and conferences, concludes international treaties, including with Azerbaijan.

Chapter II, Article 4 of the UN Charter says that 'Membership in the United Nations is open to all other peace-loving states which accept the obligations contained in the present Charter and, in the

judgment of the Organization, are able and willing to carry out these obligations'. The long-ago established and successful Nagorno-Karabakh Republic (Artsakh Republic) accepts all of the obligations of the UN Charter and certainly deserves a place in the UN, has all UN membership qualifications. The NKR's participation in the UN is necessary because it will help prevent the implementation of the plans of the Azerbaijani leadership to organize another genocide against the people of the NKR.

Second international expert conference **"The Dialogue of Nations. The right of peoples to self-determination and building of a multipolar world"** appeals to the UN:

1. To offer the Nagorno-Karabakh Republic to become the UN member;
2. To condemn the violation by Azerbaijan of the UN Security Council Resolutions from 1993, No. 822, 853, 874, 884, resulting in the continuation of hostilities in the form of the escalation of sabotage and terrorist attacks on the NKR, threats to resort to military force again, the refusal of hostile acts in the form of economic, transport and energy blockade of Armenia and Nagorno-Karabakh, the refusal of direct negotiations with the Nagorno-Karabakh Republic;
3. To urge to restore an official trilateral format of negotiations 'Azerbaijan – Nagorno Karabakh – Armenia', adopted in the OSCE official decisions of the Budapest summit of December 1994 and Prague Summary of the current OSCE Chairman from 31 March 1995 on three sides of the conflict;
4. To condemn the systematic genocidal anti-Armenian propaganda of Azerbaijan in mass media and the education system, the threat of official Baku to shoot down civilian planes flying to the capital of the NKR Stepanakert;
5. To urge Azerbaijan to respect the UN Charter and international law and recognize the concept of peaceful coexistence and co-prosperity based on mutual recognition of the NKR and Azerbaijan.

## **Pridnestrovian Moldavian Republic**

The participants of the international expert conference 'The Dialogue of Nations. The right of peoples to self-determination and building of a multipolar world' agreed that for the last 26 years of its existence the Pridnestrovian Moldavian Republic has built a full-fledged statehood, has de facto sovereignty, determines and implements foreign and domestic policy based on the will of the people. The Transnistrian government in its policy is committed to building friendly and good-neighbourly relations

with neighboring states and the world community, able and willing to contribute to the strengthening of international security, dynamic development of world economic relations.

Delegates of the forum are convinced that the people of Transnistria openly, democratically and thoroughly exercised their right to self-determination enshrined in the founding documents of the UN. Therefore, statehood of the Pridnestrovian Moldavian Republic deserves international legal recognition that, in the opinion of the conference participants, will fully contribute to strengthening stability and security on the European continent.

## Republic of Somaliland

Somaliland's Foreign Policy is guided by the goals of securing international recognition of the sovereignty of the Republic Somaliland; protecting Somaliland's statehood and territorial integrity within its 26 June 1960 borders; attracting foreign direct investment and development assistance in line with Somaliland's National Development Plan (NDP), and promoting international cooperation and good neighborly relations.

Somaliland works in partnership with the international community to strengthen peace and stability within its territory and the region, and participates in international initiatives aimed at combating terrorism, piracy, extremism and organized crime. It aims to strengthen its relationship with regional and multilateral agencies such as the intergovernmental Authority on Development (IGAD), the African Union (AU), and the United Nations (UN) and work together with its neighbors to enhance regional diplomatic and economic integration.

As a conclusion of the second international expert conference **“The dialogue of nations. The right of people to self-determination and building a multipolar world”** Republic of Somaliland appeals to all United Nations member states to:

Affirming that political self-determination a right of “all peoples” expressed in the United Nations Charter and the International Covenant on Civil and Political Rights.

1. Reminding member states that numerous United Nations studies on the right to self-determination set out factors of a people that give rise to possession of right to self-determination: a history of independence or self-rule in an identifiable territory, a distinct culture, and a will and capability to regain self-governance,

2. Fully alarmed that many member states are in open violation of their «jus cogens» and «erga omnes» obligations to defend the principle of self-determination,

3. Reminding Somaliland is a country with a history of its own, whose borders were demarcated in the late nineteenth century and legally mapped as “Promulgated State” by the British Crown in early 1930s of this century, we have effectively been in existence in one form or the other in over a hundred years of time past. On the 26th of June 1960 we gained our independence, and on that faithful morning thirty-eight countries, including the then five permanent members of the United Nations Security Council (UNSC) at that time,

4. Reminding for the last 25 years all previous Secretary General of the United Nations, that foremost international guardian of global justice, has gone out of their ways to block our case from reaching the United Nations Security Council for even a consideration and legal evaluation. In more than dozen reports they had submitted to the Security Council about former republic of Somalia, they had deliberately refrained from mentioning the name Somaliland and its withdrawal from the failed union with Somalia,

5. Fully alarmed Since Quarter of century, the mind of the world leaders didn’t face the reality on the ground and they use irrational decisions on issues, without the examination of causes or the consideration of its merits. We in Somaliland have suffered in this cruel and dangerous world for 25 long years. No body and I mean no Government and no leader with moral international authority have listened even briefly, to the fundamentals of our case or the moral merits of our cause,

6. Calls what is important now however, is that we are still suffering victims; but luckily for the first time we are sending our appeal before a tribunal of men who have the moral and legal authority to redress wrong that was done to us and enforce the right we in Somaliland justifiably owe to decent justice with sovereign state.

## Kingdom of Hawai'i

The United Nations Charter provides the rest of the authority to do it.” An autonomous independent sovereign nation-state contemplated under Article 1 of the 1933 Montevideo Convention on Rights and Duties of States requiring the state as a person of international law possessing the four qualifications of (a) a permanent population, (b) a defined territory, c) government; and (d) capacity to enter into relations with the other states.

As this Proclamation is written I offer the opportunity for Unity. Unity that as we get rid of the old we bring forth a New Vision of Governance, respect and Unity as the Human Family living in Harmony with the Natural World, it's Gods and each other.

1. Reminding: All member states of the United Nations of their commitment to protect the right of self-determination,
  2. Affirming: That political self-determination is a right of “all peoples” expressed in the United Nations Charter and the International Covenant on Civil and Political Rights and the Law of Nations.
  3. Reminding: Member states that numerous United Nations studies on the right to self-determination set out factors of a people that give rise to possession of the right to self-determination: a history of independence or self-rule in an identifiable territory, a distinct culture, and a will and capability to regain self-governance,
  4. Fully alarmed: That many member states are in open violation of their jus cogens and erga omnes obligations to defend the principle of self-determination by failing to acknowledge and act to prevent the genocide of the Native Hawaiian population,
  5. Fully alarmed: That many member states are in open violation of their erga omnes by failing to support restoration of the Kingdom of Hawai'i to its rightful place within the community of nations,
  6. Calls: Upon all member states of the United Nations to reaffirm and defend the right of self-determination,
  7. Calls: Upon the General Assembly of the United Nations to censure all member states that block, impede, or otherwise disregard their obligation to respect the right of self-determination,

8. Reminding: That the United States had direct involvement in the destruction of the Kingdom of Hawai'i Government and the illegal annexation of the Kingdom to the United States,

9. Reminding: That the United States deceived the United Nations with false representations resulting in the Kingdom of Hawai'i being removed from the United Nations List of Non-self-governing Territories,

10. Calls: Upon all member states of the United Nations to reaffirm and defend the right of the Kingdom of Hawai'i to be restored to the community of nations,

11. Calls: All member states to recognize the restored Kingdom of Hawai'i Government under its King, Edmund Keli'i Silva, Jr., whose blood line is direct to Ancient Kings and Queens of Hawai'i and who has satisfied the requirements of statehood found in the Montevideo Convention on Rights and Duties, which gives the authority for the Kingdom Government to be reborn and rejoin the community of nations as a full member State within the United Nations,

12. Calls: All members to support His Majesty's Letter to Pope Francis calling upon the Pope to rescind the Papal Bull on the Doctrine of Discovery, a Catastrophic Genocidal Evil Document, which must be rescinded, so that First Nations Indigenous Peoples and all Indigenous peoples be made whole,

13. Stresses: This right of self-determination also extends to member States of all political and economic unions.

## **State of BorinKen**

As a conclusion of the second international expert conference "**The dialogue of nations. The right of people to self-determination and building a multipolar world**" State of Borinken appeals to H. E. Ban Ki-moon, Secretary General of the UN, to place the Application for Membership before the representatives of the Security Council, petitioned by the National Sovereign State of Borinken (Puerto Rico) on July 12, 2014, as stated by Rule 59 of the Security Council.

Request the General Assembly to accredit the National Sovereign State of Borinken, the solely representative of the Boricua People, as an Observer Entity, while the Security Council considers the petition for membership.

We also request the United Nations to demand from the U.S. government to liberate our oldest political prisoner Oscar López Rivera who has been in prison for more than 34 years and Ana Belén Montes.

1. The UN general Assembly should conduct a special session to reconsider the principle of Nations' right for self-determination.
2. The UN should protect the diplomatic status of any peaceful separation movement based on the rights of nations for self-determination.
3. To create at UN a special department for negotiating the problems of separatists and try to find a consensus and solutions with their existing governments to remove obstacles.

1. Catalonia is a nation, with its own history, language, culture and collective identity with long periods of sovereignty and persevering on the recuperation of that, when it has been subjected to other states.

2. The Catalan national identity, under the Spanish State in all periods, has been persecuted, despised or ignored. The treatment received by Spain has been and continues being an extraction of Catalanian wealth without returning the proportional benefits as per their weight in the whole of Spain, leading to a permanent grievance suffered by all Catalan citizens.

3. The agreement to setup a democratic way with Spain to exercise the right to self-determination has been repeatedly rejected by Spain. The path taken to achieve full recovery of sovereignty, in fact, the independence, is exclusively peaceful and democratic and based on the free choice of the citizens of Catalonia and the decision of its Parliament.

The recognition of the right to self-determination of Catalonia is a just cause, which follows the international law requirements and is an example of collective democratic action. But it is also a recognition of the individual right to enjoy a national identity shared by society. Complete freedom of human beings should include the mechanisms to determine by democratic way, who holds sovereignty over the community, to which belongs.

It's for this reason we apply to the United Nations, for a positive and expressly manifest on respect to the right to self-determination for Catalonia.
